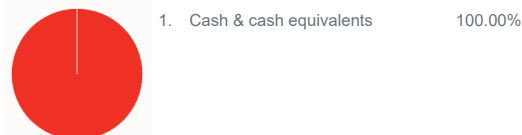

\* as percentage of NAV.

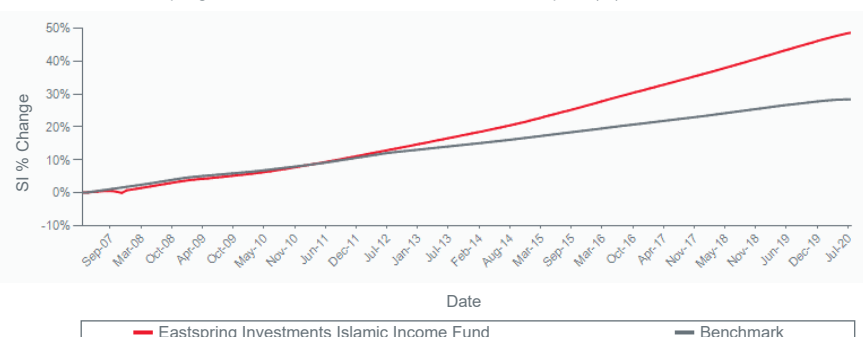

### FUND MANAGER'S COMMENTARY

BNM reduced the OPR by 25bps to 1.75% on 7 July for the fourth time this year. Since the start of the year, the OPR has been slashed by a total of 125bps. Following the recent cut, short-term interbank rates were adjusted downwards in tandem, with the overnight and 1-week rates dropped from 1.98% - 2.04% to 1.73% - 1.79%, while the 1-month rates fell from 2.15% to 1.87%.

Similarly, the rate cut effect spilled over to the short-term Bills market, shifting the yields lower by 25-26bps across the curve. Both 1-month and 1-year yields ended the month at 1.77% and 1.79% respectively.

Short-term interbank rates are expected to stay low with intervention by BNM and only to trend lower upon further rate cut announcement.
