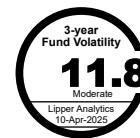

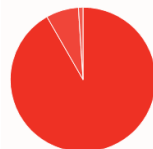

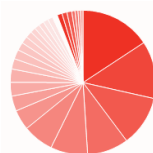
ASSET ALLOCATION*

The Lipper Leaders Ratings System is a set of tools that guide investors and their advisors to select funds that suit individual investment styles and goals. It uses investors-centred criteria to deliver a simple, clear description of a fund's success in meeting certain goals, such as preserving capital or building wealth through consistent strong returns.

Lipper Leader ratings are derived from highly sophisticated formulas that analyse funds against clearly defined criteria. Each fund is ranked against its peers based on the metric used (such as Total Return or Expense), and then the top 20% of funds in that ranking receive the Lipper Leader designation. Lipper Leaders measures are not predictive of future performance, but they do provide context and perspective for making knowledgeable fund investment decisions.

FUND MANAGER'S COMMENTARY

March 2025 was characterised by rising geopolitical tension and economic concerns but fixed income markets delivered mixed returns. The JP Morgan Asia Credit Index posted a slight gain of 0.09%. However, the JP Morgan EMBIGD Index declined by 0.76%. The US Federal Reserve kept interest rates at 4.25%-4.50% at the March FOMC meeting. Chairman Jerome Powell expressed concerns about high inflation and slower economic growth. In the US, inflation is approaching the central bank's 2% target level but remains elevated. The annual rate of inflation narrowed to 2.8% in February, driven primarily by energy prices. Meanwhile, the US unemployment rate rose to 4.1% in February, which was higher than expected. Surveys of households and businesses showed a rise in uncertainty about the economic outlook.

US Treasury yields moved in a narrow range over the month. The 10-year US Treasury yield climbed by 4 basis points to 4.25%, while the 2-year note yield declined by 8 basis points to 3.91%. The US dollar continued to depreciate against most major developed country currencies.

Hard currency emerging market debt declined on the back of wider credit spreads. High yield names underperformed investment grade. Both Lebanon and Ukraine were notable underperformers, along with Ecuador. Across regions, Africa and Emerging Europe recorded the lowest returns. Within the Asian USD credit universe, credit spreads on the JP Morgan Asia Credit Index widened from 177 basis points to 193 basis points, reaching its highest level since October 2024. Asian high yield USD bonds outperformed investment grade on the back of higher carry returns. Across sectors, real estate, transport and financials delivered the best returns while diversified and miners lagged peers.
