FUND OVERVIEW

This Fund aims to provide investors with a high level of liquidity[^] whilst providing reasonable returns by investing in low risk investments.

Note: [^]Redemption monies of the Fund will generally be paid the day following the next business day after receipt by the Manager of request to repurchase.

The Fund's asset allocation is as follows:

- 90% to 100% of Net Asset Value (NAV): Investments in debt securities, money market instruments and placements of deposits ("Permitted Investments") with financial institutions which have a remaining maturity period of not more than 397 days;

- 0% to 10% of NAV: Investments in debt securities, money market instruments and placements of deposits with financial institutions which have a remaining maturity period of more than 397 days but less than 732 days.

The Fund is suitable for investors who:


- Require a high level of liquidity, are conservative, seek capital preservation;

- seek reasonable returns that commensurate with the low risks and prefer a short term investment horizon.




