- up to 5% of NAV: Investments in cash and cash equivalents.

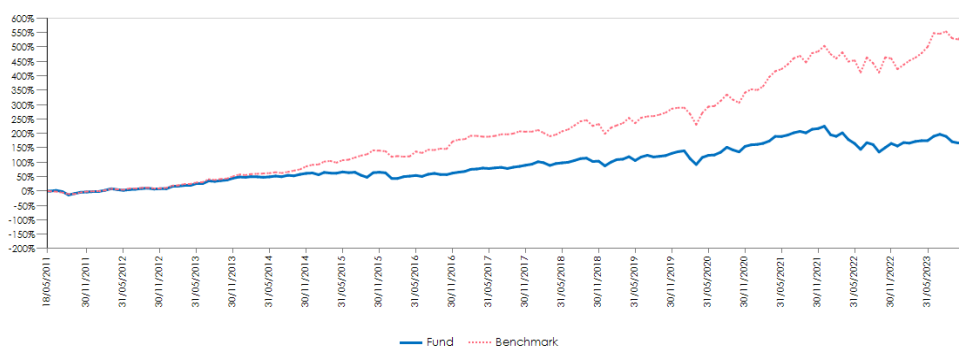

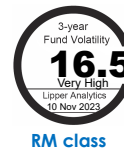
