## BRIEF INFORMATION ON CIMB-PRINCIPAL SMALL CAP FUND

CIMB-Principal Small Cap Fund is an equity fund issued by CIMB-Principal. The Fund aims to provide growth to the value of Unit holders' investments over the long-term in an equity fund by investing in undiscovered smaller companies listed on Bursa Malaysia.

This is neither a capital protected nor capital guaranteed fund.

## PRODUCT SUITABILITY

The recommended investment timeframe for this Fund is five (5) years or more. This Fund is suitable for investors who:

- have a long-term investment horizon;
- want to diversify their overall investment portfolio by including shares as an asset class, in particular, shares of smaller companies;
- are seeking capital appreciation over the long-term; and/or
- can accept that investment returns may fluctuate significantly over the short-term and may even be negative.
