## **BRIEF INFORMATION ON THE PRODUCT**

## 1. What is this product about?

AHAM Select Income Fund is an open-ended fixed income fund, issued and managed in-house by the Manager.

The Fund's investment objective is to provide investors with a steady and regular income stream in the form of distributions over the medium to longer term.

#### **PRODUCT SUITABILITY**

#### 2. Who is this product suitable for?

The Fund is designed for retail investors who are relatively conservative with a bias towards receiving regular income and want a meaningful medium to long-term capital growth.

## 3. What am I investing in?

	The Fund will focus on achieving its objective by investing in a diversified portfolio consisting
	a minimum of 70% of its NAV in debentures, money market instruments and/or deposits, and a maximum of 30% of its NAV in equities. The portfolio composition is aimed at providing investors with a regular income, as well as potential capital growth through price appreciation of its investments. The Fund will invest primarily in Asia Pacific ex Japan companies. The Fund may also invest a smaller portion of its NAV in other regions.
	We will combine a top-down and bottom-up investment approach to identify investment opportunities. When making investment decisions for debentures, money market instruments and deposits, macroeconomic trends and market analysis are the important considerations in deriving the top-down perspective on interest rate outlook, fixed income market and currency movement. For its bottom-up approach, we would conduct analysis on the issuers to assess its ability to service its debt obligations.
Investment strategy	The Fund's investment in debentures would consist of government and corporate bonds. The selection of debentures will not be constrained by credit ratings of issuances. However, the selection will depend largely on its quality where the respective issuers display strong ability to meet their financial obligations, healthy cash-flow, the collateral type, value, claims priority as well as offer highest safety for timely payment of interest and principal.
	For its equity portion, the Fund intends to focus on dividend yielding equities with the aim of enhancing income and returns for the Fund. As such, we would adopt a bottom-up strategy where individual stock analysis forms the primary building blocks for portfolio construction and stock selection. The Fund focuses on higher dividend paying sectors where cash flows are more resilient, and selected lower dividend yielding stocks with prospects of growing its dividends to achieve an element of capital growth in addition to dividend yield on a total return basis.
	Key factors which are useful to the identification of such companies would include sales and profit growth, financial strength and gearing levels, capital expenditure levels as well as management's commitment towards rewarding shareholders via dividends or capital



repayments. The dividends provided by these companies would be a source of income from which the Fund would then declare income distributions to you.

To achieve its objective, the Fund will also have the flexibility to invest in warrants, as well as collective investment schemes that have similar investment objective to the Fund.

#### Foreign investments

For the Fund's exposure into debentures, the Fund will hold the ability to access investment opportunities through issuances made in global markets. While the Fund's exposure into equities will have a similar flexibility, we will look towards a minimum of 80% of the Fund's equity exposure into companies listed within the Asia Pacific ex Japan region, and have the flexibility to invest up to 20% of the Fund's equity exposure into companies listed on global markets outside the Asia Pacific ex Japan region.

#### **Derivatives and Embedded Derivatives**

Derivative trades may be carried out for hedging purposes through financial instruments including, but not limited to, forward contracts, futures contracts and swaps. Future and forward contracts are generally contracts between two parties to trade an asset at an agreed price on a pre-determined future date. Swaps, whereas is an agreement to swap or exchange two financial instruments between two parties.

The intention of hedging is to preserve the value of the asset from any adverse price movements. For example, to hedge against foreign currency exchange risk, the Fund may enter into a currency forward contract to offset any adverse foreign currency movements by determining an agreed rate for an agreed tenure with its counterparty. While the hedging transactions will assist with mitigating the potential foreign exchange losses by the Fund, any potential foreign exchange gains from the hedging strategy will be capped as well.

The Fund may also invest in embedded derivatives such as, but not limited to, equity-linked notes, and credit-linked notes. Investment in these embedded derivatives will provide the Fund with the exposure to the reference asset. Each of these embedded derivatives has its own targeted maturity and will expose investors to the price fluctuations of, in the case of an equity-linked note, the stock that the equity-linked note is linked to. As a result, any fluctuation in the price of the embedded derivatives may also lead to fluctuations in the NAV of the Fund i.e., if the price of the embedded derivative sees a drop in price, the NAV of the Fund will also be negatively impacted. As the embedded derivative is structured by an external party, investments in an embedded derivative will also expose the Fund to counterparty risk, which we will attempt to mitigate by carrying out a stringent selection process on its counterparty prior to an investment being made. Risks associated with the investments in embedded derivative will also be mitigated by limiting the Fund's total exposure to not more than 10% of the Fund's NAV.

The Fund adopts commitment approach to measure the Fund's global exposure to derivatives and embedded derivatives. The commitment approach is a methodology that aggregates the underlying market values or notional values of derivatives and/or embedded derivatives after taking into account the possible effects of netting and/or hedging arrangements. The Fund's global exposure from the derivatives position must not exceed 100% of NAV of the Fund at all times.

#### Temporary Defensive Position

We hold the option to take temporary defensive positions that may be inconsistent with the Fund's principal strategy and asset allocation to protect the Fund against adverse market conditions that may negatively impact the financial markets. To manage the risk of the Fund, we may shift the Fund's focus and exposure into lower risk investments such as money market instruments and/or deposits.

#### 5. What are the possible outcomes of my investment?

This is a fixed income fund that invests a minimum of 70% in debentures, money market instruments and/or deposits, and a maximum of 30% in equities within the domestic and investable foreign markets.

The performance of the Fund would be dependent on the debentures, money market instruments and/or deposits, and equity markets that are investable by the Fund. The Fund's performance is reliant on the Manager's expertise in managing the Fund to meet its objective.

Unlike fixed deposits which generally provide a guarantee on capital invested and carry specific rate of return, the Fund's investments into debentures and money market instruments do not provide a guarantee on capital contributed nor does it guarantee a fixed rate of return.

The Fund's investment into equities would to a great extent, be linked to the price movements of the equity markets. If the equities that are investable by the Fund performs well, the Fund's performance may reflect the same. However, should the equities that are investable by the Fund perform poorly, the Fund's performance may also be impacted negatively.

#### **KEY RISKS**

#### 6. What are the key risks associated with this product?

#### General risks

- Market risk Market risk arises because of factors that affect the entire market place. Factors such as economic
  growth, political stability and social environment are some examples of conditions that have an impact on businesses,
  whether positive or negative. Market risk cannot be eliminated but may be reduced through diversification. It stems
  from the fact that there are economy-wide perils, or instances of political or social instability which threaten all
  businesses. Hence, the Fund will be exposed to market uncertainties and fluctuations in the economic, political and
  social environment that will affect the market price of the investments either in a positive or negative way.
- Fund management risk This risk refers to the day-to-day management of the Fund by the Manager which will impact the performance of the Fund. For example, investment decisions undertaken by the Manager as a result of an incorrect view of the market or any non-compliance with internal policies, investment mandate, the Deed, relevant law or guidelines due to factors such as human error, fraudulent, dishonesty or weaknesses in operational process and systems, may adversely affect the performance of the Fund.
- Performance risk The performance of the Fund depends on the financial instruments that the Fund purchases. If the instruments do not perform within expectation or if there is a default, then, the performance of the Fund will be impacted negatively. The performance of the Fund may also be impacted if the allocation of assets is not properly done. This is where the experience and expertise of the fund managers are important and the risk on the lack of experience and expertise of the fund managers has been highlighted above. On that basis, there is never a guarantee that investing in the Fund will produce the desired investment returns or distribution of income.
- Inflation risk This is the risk that your investment in the Fund may not grow or generate income at a rate that keeps

pace with inflation. This would reduce your purchasing power even though the value of the investment in monetary terms has increased.

- Liquidity risk Liquidity risk refers to two scenarios. The first is where an investment cannot be sold due to unavailability of a buyer for that investment. The second scenario exists where the investment, by its nature, is thinly traded. This will have the effect of causing the investment to be sold below its fair value which would adversely affect the NAV of the Fund and subsequently the value of Unit Holder's investments in the Fund.
- Operational risk This risk refers to the possibility of a breakdown in the Manager's internal controls and policies. The
  breakdown may be a result of human error, system failure or may be fraud where employees of the Manager collude
  with one another. This risk may cause monetary loss and/or inconvenience to you. The Manager will review its internal
  policies and system capability regularly to mitigate instances of this risk. Additionally, the Manager maintains a strict
  segregation of duties to mitigate instances of fraudulent practices amongst employees of the Manager.
- Loan / financing risk This risk occurs when you take a loan or financing to finance your investment. The inherent risk of investing with borrowed/financed money includes you being unable to service the loan/financing repayments. In the event Units are used as collateral, you may be required to top-up your existing instalment if the prices of Units fall below a certain level due to market conditions. Failing which, the Units may be sold at a lower NAV per Unit as compared to the NAV per Unit at the point of purchase towards settling the loan/financing.
- Suspension of repurchase request risk Having considered the best interests of Unit Holders, the repurchase requests by the Unit holders may be subject to suspension due to exceptional circumstances, where the market value or fair value of a material portion of the fund's assets cannot be determined. In such case, Unit Holders will not be able to redeem their Units and will be compelled to remain invested in the Fund for a longer period of time. Hence, their investments will continue to be subject to the risks inherent to the Fund.

#### Specific risks

- Stock specific risk Prices of a particular stock may fluctuate in response to the circumstances affecting individual companies such as adverse financial performance, news of a possible merger or loss of key personnel of a company. Any adverse price movements of such stock will adversely affect the Fund's NAV.
- Credit and default risk Credit risk relates to the creditworthiness of the issuers of the debentures or money market instruments and the Financial Institutions where the deposits are placed (hereinafter referred as "investment") and their expected ability to make timely payment of interest and/or principal. Any adverse situations faced by the issuer and/or Financial Institution may impact the value as well as liquidity of the investment. In the case of rated investment, this may lead to a credit downgrade. Default risk relates to the risk of an issuer and/or a Financial Institution of the investment either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investment. This could adversely affect the value of the Fund.
- Interest rate risk This risk refers to the impact of interest rate changes on the valuation of debentures or money market instruments (hereinafter referred as "investment"). Generally, movement in interest rates affects the prices of investment inversely. For example, when interest rates rise, prices of investments will fall. The fluctuations of the prices of investment will also have an impact on the NAV of the Fund. This risk can largely be eliminated by holding investment until their maturity. We also manage interest rate risk by considering each investment's sensitivity to interest rate changes. When interest rates are expected to increase, the Fund would then likely seek to switch to investment that are less sensitive to interest rate changes. For investments in deposits, the fluctuations in the interest rates will not affect the placement of deposits but will result in the opportunity loss by the Fund if the placement of deposits is made at lower interest rate.
- Embedded derivatives risk The NAV of the Fund will be impacted by the valuation of the embedded derivatives. Factors that may impact the valuation of the embedded derivatives will include, but not be limited to movement of the underlying asset, volatility of the underlying assets, interest rate levels, the correlation of the underlying assets and other such factors. Any change in the aforesaid factors would either positively or negatively impact the valuation of the embedded derivatives hence impacting the NAV of the Fund. As such, the Fund's NAV will be exposed to potential price volatility, which will be dependent on the valuation of the embedded derivatives that the Fund invested in.
- Warrants investment risk The value of the warrants will depend on the pricing of the underlying security whereby the growth and performance prospect of the underlying security would consequentially affect the value of the warrants. In addition, the value of the warrants may decrease exponentially as the warrants approach its maturity date and the potential gains from a favourable price movement of the underlying may be offset by aggressive time decay. We may consider unwinding these warrants if there are material adverse changes to its value with the aim to mitigate the risk.
- Country risk Investments of the Fund in any countries may be affected by changes in the economic and political climate, restriction on currency repatriation or other developments in the law or regulations of the countries in which the Fund invests in. For example, the deteriorating economic condition of such countries may adversely affect the value of the investments undertaken by the Fund in those affected countries. This in turn may cause the NAV of the Fund or prices of Units to fall.



- Currency risk As the investments of the Fund may be denominated in currencies other than the base currency of the
  Fund, any fluctuation in the exchange rate between the base currency of the Fund and the currencies in which the
  investments are denominated may have an impact on the value of these investments. You should note that any gains
  or losses arising from the fluctuation in the exchange rate may further increase or decrease the returns of the
  investment.
- Regulatory risk The investments of the Fund would be exposed to changes in the laws and regulations in the
  countries the Fund is invested in. These regulatory changes pose a risk to the Fund as it may materially impact the
  investments of the Fund. In an effort to manage and mitigate such risk, the Manager seeks to continuously keep abreast
  of regulatory developments (for example, by closely monitoring announcements on regulators' website and mainstream
  media) in that country. The Manager may dispose its investments in that particular country should the regulatory
  changes adversely impact the Unit Holders' interest or diminish returns to the Fund.
- Distribution out of capital risk The Fund may distribute income out of capital. Such capital distributions represent
  a return or withdrawal of part of the amount of your original investment and/or capital gains attributable to the original
  investment and will result in a reduction in the NAV per Unit of the Fund and reduce the capital available for future
  investment and capital growth. Future capital growth may therefore be constrained.

For the financial year ended 28 February 2025 (1 March 2024 to 28 February 2025), the Fund registered a return of 4.59% compared to the benchmark return of 3.49%. Since commencement, the Fund has registered a cumulative return of 200.98% compared to the benchmark cumulative return of 132.94%, outperforming by 68.04%.

Effective 18 July 2015, the benchmark of the Fund have been changed from JP Morgan Asia Credit Investment Grade Index, weighting at 70% for the fixed income investments and Dow Jones/Asia Pacific Select Dividend 30 Index, weighting at 30% for the equities investment to Maybank 12- month fixed deposit rate, weighting at 70% for the fixed income investments and Dow Jones/Asia Pacific Select Dividend 30 Index, weighting at 30% for the equities investment which is reflective of the asset allocation and investment strategy of the Fund. The Maybank 12-month fixed deposit rate has been selected as it aims to reflect the performance of the investment opportunities related to investments into fixed income instruments. The Maybank 12-month fixed deposit rate represents the performance benchmark relating to interest bearing instruments.

Please note that the change in the benchmark will not impact nor change the asset allocation or investment strategy of the Fund.

## Basic of calculation and assumption made in calculating the returns

The performance figures are a comparison of the growth/decline in NAV for the stipulated period taking into account all the distribution payable (if any) during the stipulated period.

#### An illustration of the above would be as follow:-

Capital return = NAV per Unit end / NAV per Unit begin - 1

Income return = Income distribution per Unit / NAV per Unit ex-date

Total return = (1+Capital return) x (1+Income return) - 1

Bursa Malaysia	Means the stock exchange operated by Bursa Malaysia Securities Berhad including such other name as it may be amended from time to time.
Business Day	Means a day on which Bursa Malaysia and/or one or more of the foreign markets in which the Fund is invested in are open for business/trading.
Deed	Refers to the deed dated 9 December 2004, first supplemental deed dated 16 November 2005, second supplemental deed dated 18 June 2007, third supplemental deed dated 15 October 2008, fourth supplemental deed dated 18 January 2012, fifth supplemental deed dated 27 June 2014, sixth supplemental deed dated 22 July 2015, seventh supplemental deed dated 28 April 2017, eighth supplemental deed dated 5 October 2018 and ninth supplemental deed dated 24 August 2022 entered into between the Manager and the Trustee.
deposit(s)	Has the same meaning as the definition of "deposit" in the Financial Services Act 2013. For the avoidance of doubt, it shall exclude structured deposit.
Financial Institution(s)	Means:  a) if the institution is in Malaysia—  (i) licensed bank;  (ii) licensed investment bank; or  (iii) licensed Islamic bank; or  b) if the institution is outside Malaysia, any institution that is licensed, registered, approved or authorised by the relevant banking regulator to provide financial services.
Fund	Refers to the AHAM Select Income Fund.
licensed bank	Means a bank licensed under the Financial Services Act 2013.
licensed investment bank	Means an investment bank licensed under the Financial Services Act 2013.
licensed Islamic bank	Means an Islamic bank licensed under the Islamic Financial Services Act 2013.
long-term	Means a period of more than five (5) years.
the Manager / AHAM / we / us / our	Refers to AHAM Asset Management Berhad.
medium to long-term	Means a period between three (3) to five (5) years.
MYR	Ringgit Malaysia.
Net Asset Value or NAV	Means the value of the Fund's assets less the value of the Fund's liabilities at a particular valuation point.
NAV per Unit	Means the NAV of the Fund at a particular valuation point divided by the number of Units in Circulation at the same valuation point.
Prospectus	Means the prospectus of the Fund and includes any supplementary or replacement prospectus, as the case may be.
Repurchase Charge	Means a charge imposed pursuant to a repurchase request.
Sales Charge	Means a charge imposed pursuant to a purchase request.
SC	Means Securities Commission Malaysia.
Trustee	Refers to HSBC (Malaysia) Trustee Berhad.
Unit(s)	Means a measurement of the right or interest of a Unit Holder in the Fund.
Units in Circulation	Means Units created and fully paid and which have not been cancelled. It is also the total number of Units issued at a particular valuation point.
Unit Holder(s), investor(s), you	Means the person / corporation registered as the holder of a Unit or Units including persons jointly registered.
