Asian stock markets closed broadly lower on Monday, as uncertainty over US tax reform continued to weigh on sentiment and investors awaited a number of data points, including US and UK inflation data. Chinese stocks continued to rise, however, driven by financials and Beijing's deregulation of the sector.

European stock markets closed lower on Monday, although they recovered somewhat towards the end of the trading day after the US markets started to rise. Reports that UK Prime Minister May's leadership was to be challenged by members of her party and continued concerns over the lack of progress on Brexit negotiations weighed on markets.

US stock markets closed higher on Monday after initial weakness, partly due to the uncertain outlook for tax reform, subsided. It was a quiet day for US economic data, with investors watching for any progress from President Trump's Asia tour and awaiting the release of data points later in the week.

US treasury yields rose marginally on Monday, as investors awaited the release of US inflation and growth data this week. Investors also anticipated speeches by key central bank heads at the European Central Bank on Tuesday.

Crude oil futures gained amid speculation OPEC would extend its supply cuts at its meeting at the end of the month.
